**15. Warranty and Repair Provision:**

BioWave Corporation warrants the BioWavePRO and BioWave Home Neurostimulator against defects in material or workmanship for a period of ONE year from the date of original purchase. This Limited Warranty excludes the Leadwire Cable and Electrodes as well as the following items:

1. Damage caused by accident, misuse, or abuse of operation contrary to the instructions specified in the User's Manual;
2. Damage resulting from modification or attempted repair by any person not authorized in writing by BioWave Corp.;
3. Damage caused by inserting and/or using a battery not approved by or purchased from BioWave Corporation; and
4. Cosmetic damage.

To obtain warranty or repair service, you must first contact our customer service department at 1-877-BIOWAVE (1-877-246-9283) or [support@biowave.com](mailto:support@biowave.com) to receive a return manufacturer's authorization number (RMA#). Once you have obtained an RMA#, return your BioWavePRO or BioWaveHOME unit via UPS or FEDEX in either its original packaging or packaging affording an equal degree of protection to BioWave Corporation.

**Returned Goods Policy:**

If a BioWave neurostimulator unit is damaged, BioWave will assess the damage and deduct the repair cost from the amount being refunded. BioWave cannot receive back opened electrode packages. The ordering facility pays shipping costs for return of any item. There is no restocking fee.

There are 34 trained distributors whose sales representatives are located over most of the U.S. that can cover most locations. Large buying activities will be managed by a BioWave representative and/or a local sales representative who will help and provide the initial inservice and training for the healthcare providers in the ordering facilities. The sales representative will then maintain the account and provide follow up customer support and training updates. In the event there is no distributor coverage in a particular region, BioWave will identify a new distributor and train them to provide local coverage. Customer service will follow up with every end user that receives a BioWavePRO or BioWaveHOME unit to make sure they understand how to use it, to see if they have any questions regarding its operation and to ensure the device is operating properly.

**20a. Terms and conditions for Training:**

For BioWavePRO units, an inservice is scheduled and a training session is provided to the healthcare providers that will be treating end users. There is no cost for this inservice. The inservice is conducted by one of our BioWave trained sales representatives or clinical specialists.

When BioWaveHOME or BioWaveGO units are issued to end users following successful treatment in the clinic, the healthcare provider in the clinic teaches the end user how to use the BioWaveHOME or BioWaveGO unit. Since the end user controls the BioWavePRO unit in the clinic, and BioWaveHOME and BioWaveGO works exactly the same way, there is little training required for the end user since they already know the correct placement location for the electrodes and operation of the device. End users also have access to our toll free customer service number if they have any questions about how to use the BioWavePRO, BioWaveHOME or BioWaveGO devices. There is no charge for this customer service. BioWave will also routinely contact the end users to ensure that the BioWaveHOME or BioWaveGO device is operating properly and to see if the end user has any questions regarding electrode placement or operation of the device.
